**\*MUST ATTACH ALL DOCUMENTS THAT APPLY TO YOUR ESTABLISHMENT \***

- New York State Liquor License (Establishments serving alcohol)
- Emergency Exit Discharge Lighting Inspection Certificate/Affidavit
  - Nassau County Fire Marshal inspection report or letter from licensed electrician stating that all emergency exit lighting is properly functioning.
- Fire Sprinkler Inspection Certificate/Affidavit
  - Nassau County Fire Marshal inspection report or letter from licensed plumber stating that fire sprinkler is properly functioning.
- Fire/Smoke Alarm and/or "Pull Station" Inspection Certificate/Affidavit
  - Nassau County Fire Marshal inspection report or letter from alarm company stating that alarm system is properly functioning.
- Nassau County Department of Health Food Service Permit
- New York State Department of Health Operating Certificate
