

Filming and/or Photography Permit Fee Schedule

The following fee schedule covers all filming and/or photography activity within the Village of Bayville:

The filming and/or photography permit fee is \$2,500.00 per location and/or per day. A location is considered anywhere there is filming or filming-related activity(ies) such as base camp, trailer placement/storage, food trucks, or other support vehicles and staff.

For example:

If you are planning to film/photograph or conduct filming-related activity(ies) at one location over the course of one day, the permit fee would be \$2,500.00.

If you are planning to film/photograph or conduct filming-related activity(ies) at two locations on the same day, the permit fee would be \$5,000.00.

If you are planning to film/photograph or conduct filming-related activity(ies) at one location on two days, the permit fee would be \$5,000.00.

Rental of Village Facilities

If you need to rent space at a Village-owned facility to park trailers, cars, or other vehicles that are part of your filming and/or photography activity, the fee is \$2,500.00 per day.

INSURANCE REQUIREMENTS:

Permittee is required to furnish, with the application herein, a certificate of General Liability Insurance, in the name of the permittee and including the interest of the Incorporated Village of Bayville as additional insured for the ownership, maintenance and use of the designated premises. Such policy or certificate shall be written with a limit of not less than \$2,000,000 combined single limit per occurrence for bodily injury and property damage, including property in care, custody and control of the maintenance in effect during the terms of the permit.

WORKERS COMPENSATION AND NYS DISABILITY is required for all employees that will be working on site.

INDEMNIFICATION:

Permittee agrees to indemnify and hold harmless the Village of Bayville, its agents, officers and employees against all claims, demands, causes of action, costs, liabilities of every kind and nature arising out of and caused by permittee's use and occupation of the Village's property.

MAINTENANCE:

Permittee will maintain, repair and clean-up the Village's property during the same or following day after permittee's use of same, and restore such property to original condition to the satisfaction of the Village.

LAWS:

Permittee will be bound by the anti-discrimination and all other applicable laws and ordinances of the Incorporated Village of Bayville, Town of Oyster bay, County of Nassau and the State of New York.

FEE:

Permittee hereby agrees and consents to advance the payment of \$2,500 for use of the Village property as provided for herein.
