NOTICE IS HEREBY GIVEN that SEALED PROPOSALS for INSTALLATION AND EMERGENCY REPAIRS FOR WATER MAINS AND APPURTENANCES (**H2M Project No.: BAYV2350**) will be received by the Village Administrator of the Inc. Village of Bayville at the Village Hall, 34 School Street, Bayville, New York 11709, until 11:00 AM, Prevailing Time, on **Thursday, January 11, 2024**, at which time and place they will be publicly opened and read.

Checks or money orders shall be made payable to H2M architects + engineers. Plan deposit is refundable in accordance with the terms in the Information for Bidders to all submitting bids. Any bidder requiring documents to be shipped shall make arrangements with the printer and pay for all packaging and shipping costs.

As a convenience to the Contractor, Digital Bidding Documents may be obtained from the following website: www.h2mplanner.com as an online download for a non-refundable fee of **One Hundred Dollars (\$100.00)**, paid by credit card.

Please note REV and [h2mplanner.com](http://www.h2mplanner.com) are the designated locations and means for distributing and obtaining all bid package information. All bidders are urged to register to ensure receipt of all necessary information, including bid addenda. All bid addenda will be transmitted to registered plan holders via email and will be available at www.h2mplanner.com. Plan holders who have paid for hard copies of the bid documents will need to make the determination if hard copies of the addenda are required for their use, and coordinate directly with REV for hard copies of addenda to be issued. There will be no charge for registered plan holders to obtain hard copies of the bid addenda.

Each proposal submitted must be accompanied by a certified check or bid bond, made payable to the INC. VILLAGE OF BAYVILLE, in an amount not less than five percent (5%) of the total amount of the bid, as a commitment by the bidder that, if its bid is accepted, it will enter into a contract to perform the work and will execute such further security as may be required for the faithful performance of the contract.

The Owner reserves the right to reject any or all bids, waive any informalities and to accept such bid which, in the opinion of the Owner, is in the best interests of the Owner.
